Investor relief schemes (SEIS / EIS / VCT)

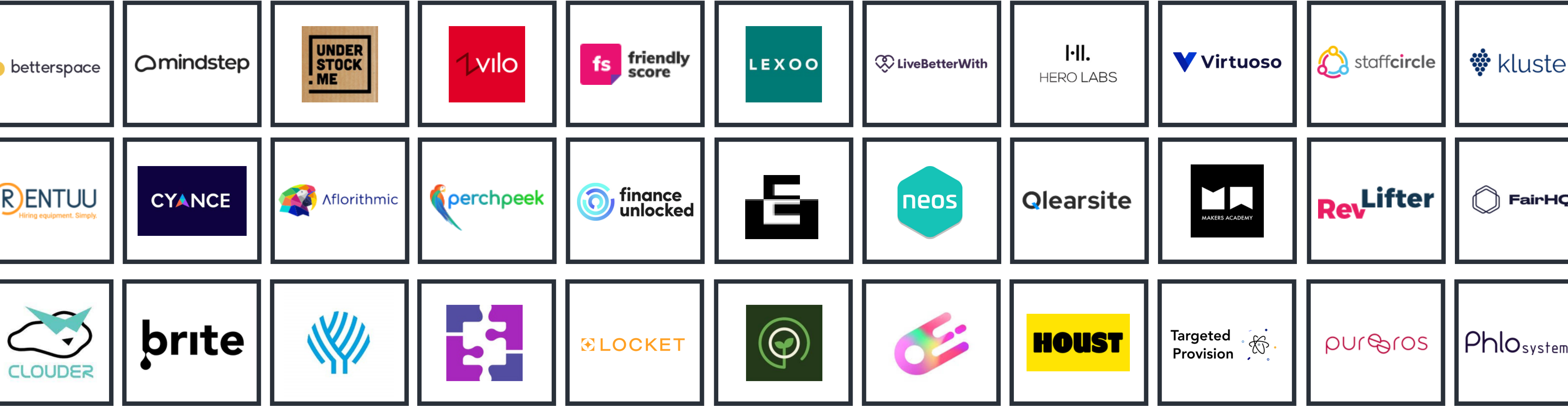
